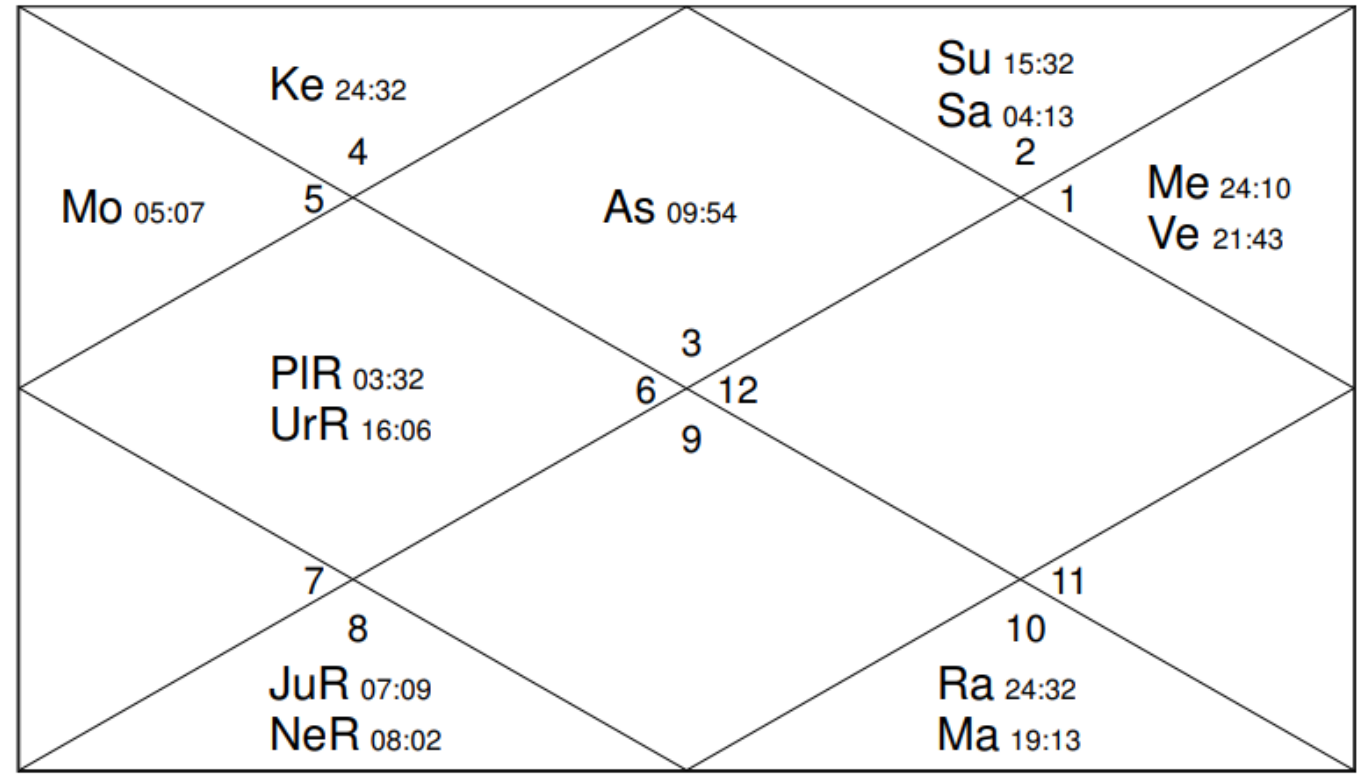

Position of Planet Jupiter in Your Birth Chart & It's Impact on You

Effect of Jupiter's Transit in Taurus by your Moon Sign
